## CHAPERONES

**Wristbands will be your ticket. Wristbands will have a barcode that will be scanned upon entry. For consignment orders, Grad Pass vouchers will be issued at the chaperone headquarters when you close out your account.**

All schools will be given **1** complimentary chaperone ticket (wristband) per **10** paid students. This includes any tickets purchased for the GRAD NITE Early Admission/Dinner package. These tickets will be clearly marked as chaperone tickets and must only be used for chaperones. All chaperone tickets are mailed with your GRAD NITE student ticket order.

All chaperones must be at least 21 years of age. Chaperones, just like students, must adhere to all GRAD NITE rules and regulations. If you have approved a chaperone to attend that is under 21 years of age, please fill out and submit the special exceptions form.

**The “Main Contact” from each School must check in to the chaperone center immediately following admission to Event.** *(Main Contact is listed on Chaperone Contact Form which is due **two weeks prior to event**. Online link will be provided a month before your Grad Nite date.)* School is required to confirm that the chaperone names and contact numbers are correct and submit any changes to the list. In the event that contact must be made with Chaperones, we request that all Chaperones be accessible throughout the event.

Six Flags Magic Mountain will provide a chaperone center for all chaperones participating in GRAD NITE. This center will be located at the **Full Throttle Sports Lounge** near Bugs Bunny World. Six Flags will use this center to communicate with all schools in case of an emergency or any other incident occurring during GRAD NITE. Chaperones must wear wristbands at all times. These wristbands will be issued with your ticket order and will allow you access to the chaperone center. Chaperones are responsible for all students and guests regardless of their age.

Six Flags understands that many chaperones go out of their way to help on this night. In an effort to show our appreciation, identified Chaperone areas **ONLY** will provide movies, meals, and refreshments at no charge.

**All chaperones participating in GRAD NITE must have knowledge of the rules and regulations and be aware that they are responsible for all students participating from their school.**

## Park Policies

**In addition to the Park Policies already in place at Six Flags Magic Mountain, the following rules and regulations apply during GRAD NITE:**

- Absolutely **NO** Alcohol, Drugs, or Weapons of any kind are permitted.
- Six Flags is a **SMOKE-FREE** Park and will not tolerate smoking in the park on GRAD NITE. If chaperones would like to smoke they must exit the park. This includes E-Cigarettes and Vaping.
- Only buses or chaperone driven vehicles will be permitted to park. Absolutely **NO** student driven vehicles will be permitted.
- No student or guest of a student will be permitted to leave Grad Nite prior to park closing unless accompanied by a chaperone.
- ALL Vehicles attending the GRAD NITE Early Admission/Dinner package should arrive no earlier than 8:00 pm and Vehicles attending GRAD NITE only, should arrive no earlier than 10:30 pm.
- No outside food, drink, coolers or other food containers are permitted.
- ALL students and guests are required to adhere to the Dress Code provided or entrance to GRAD NITE may not be permitted.

## DRESS CODE

**All students must adhere to their schools dress code policies and must meet, at a minimum, Six Flags Magic Mountain's standard park dress code. We offer a suggested list of clothing/items to help with no delays in entry. It is the school's responsibility to ensure all participants are dressed appropriately prior to arriving at Grad Nite.**

Anyone not adhering to the event dress code may have delayed entry into the park and may not be granted admission without finding alternate clothing.

### SIX FLAGS PARK DRESS CODE

In keeping with our family-friendly environment, and for safety reasons, Six Flags enforces a dress code. Proper attire must be worn in the park at all times, including shirts and appropriate footwear. Clothing or tattoos with offensive language or graphics are not permitted at any time.

Examples of clothing **NOT** permitted are those displaying:

- Profanity
- Pornography
- Graphic violence
- Support of drugs and drug use
- Gang symbols
- Promotion of discrimination against any group
- Mask and hoodies with face covers

#### ***Suggestions of what to wear/bring:***

- Drawstring backpacks
- Purses (sized 8.5 x 11)
- Jeans or leggings/yoga pants
- T-Shirts
- Blouse, Sweater or Top

#### **Remember:**

- Six Flags Security has the right to refuse admission to anyone they deem not appropriately dressed for the event.
- Any student or guest not permitted because of dress code must remain accompanied by a chaperone until a resolution has been found.
- Temperatures drop overnight – it is recommended to avoid wearing shorts, skirts, or dresses.

## GENERAL INFORMATION

- Chaperones may bring in laptops/iPads & backpacks (emergency contacts, medical forms, etc.)
- Movies will be available in Golden Bear Theatre

### Illnesses/ First Aid:

- In the instance a student becomes ill a chaperone will be notified and be directed to the First Aid Station located next to DC Universe.
- If an illness is considered major and the student needs to go to a hospital a chaperone will be required to accompany them to the hospital as well as contact their parents/guardians.

### Students with Special Needs:

- Please complete the Special Exceptions form for any student requiring assistance.
- Wheelchairs are available for rent. Wheelchair rentals are located behind the Guest Relations building in Six Flags Plaza.
- Six Flags' Attraction Access Program is designed to accommodate guests with disabilities or certain other qualifying impairments so they may participate in the enjoyment of our Parks. For more information on how to obtain an Attraction Access Pass see below:

**To receive an Attraction Access Pass** you must have a note from a doctor. You will only need this note the first time you request an Attraction Access Pass. Your doctor should include the following information:

- Doctor's name
- Address of the doctor's practice (Printed stationary is OK as long as it includes the Doctor's medical ID number)
- Phone number of doctor's practice (Printed stationary is OK as long as it includes the Doctor's medical ID number)
- Name of person requesting the Attraction Access Pass
- Statement indicating the guest has a disability or other qualifying impairment under the Americans with Disabilities Act (ADA) and/or applicable state law that prevents the guest from waiting in a standard queue.
- Valid time period of disability (permanent or, if temporary, the valid time period the Pass is needed for)
- Doctor's signature
- **The note must NOT describe or indicate the nature of the disability.**

Bring your note to the Ride Information Center (Guest Services) just inside the front gate of the park. A photo identification must be presented at the time of issuance. For children under the age of 16, a student photo ID will be acceptable. You will only need to present your doctor's note the first time you visit a U.S. Six Flags theme park.

### Special Exceptions:

- Completed Special Exceptions Form must be submitted one week prior to date of event.
